WTDC-17: ICTs for Development

We were warmly welcomed recently in Buenos Aires for the World Telecommunication Development Conference 2017 (WTDC-17), from 9 to 20 October, by the Government of Argentina, to whom I express my sincere thanks. The conference attracted over 1360 participants from 134 Member States.

The **Buenos Aires Declaration** we adopted is our vision for the future. It sends a strong message from the information and communication technology (ICT) community to the world about our contribution to the attainment of the United Nations Sustainable Development Goals (SDGs).

The Strategic Plan we endorsed will guide us to implement the Buenos Aires Declaration, while the Buenos Aires Action Plan will shape our daily work.

We also adopted five regional initiatives per region that will be cascaded into concrete projects, that I am deeply convinced, will make a difference in the lives of people on the ground.

We organized 13 **side events** on themes related to ICT for SDGs, and we celebrated the **25th anniversary** of the ITU Telecommunication Development Sector (ITU-D).

I would like to thank all the WTDC-17 side events and anniversary sponsors, in particular the Kingdom of Saudi Arabia, Platinum sponsor of the 25th anniversary celebrations.

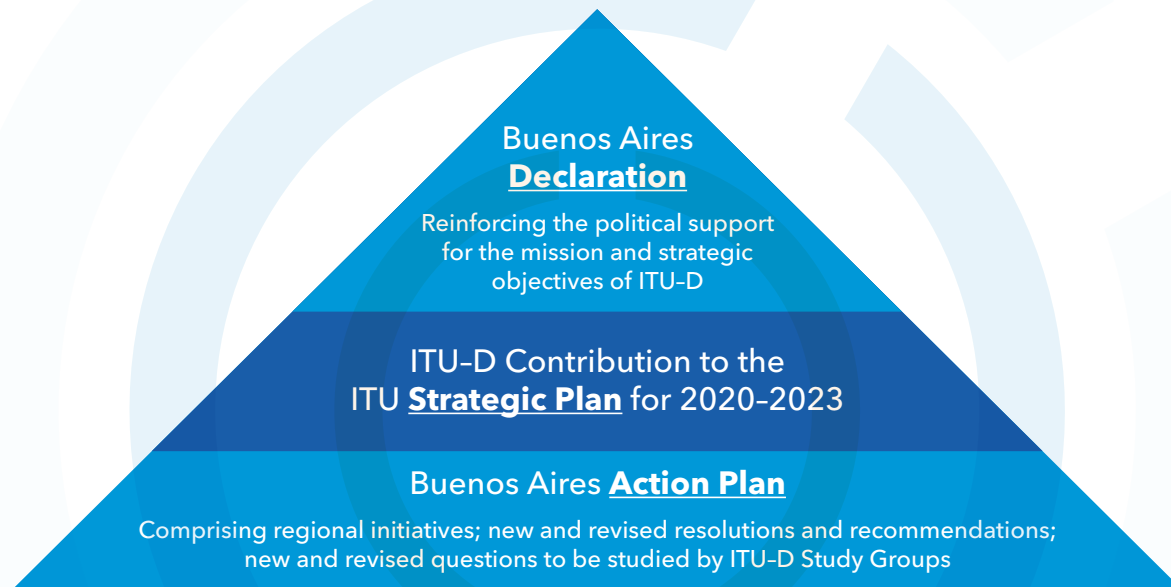

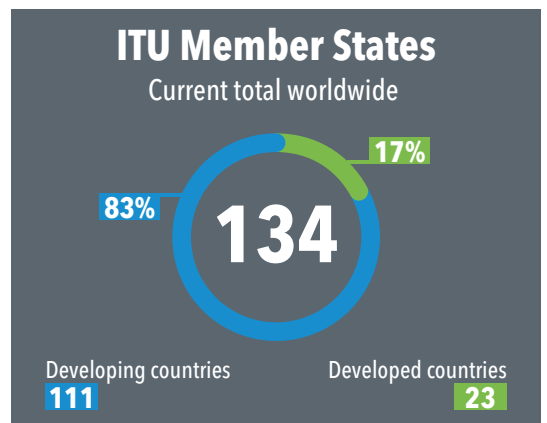

By region

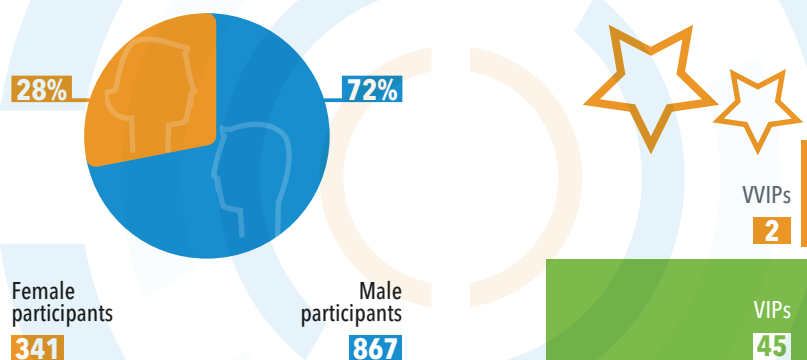

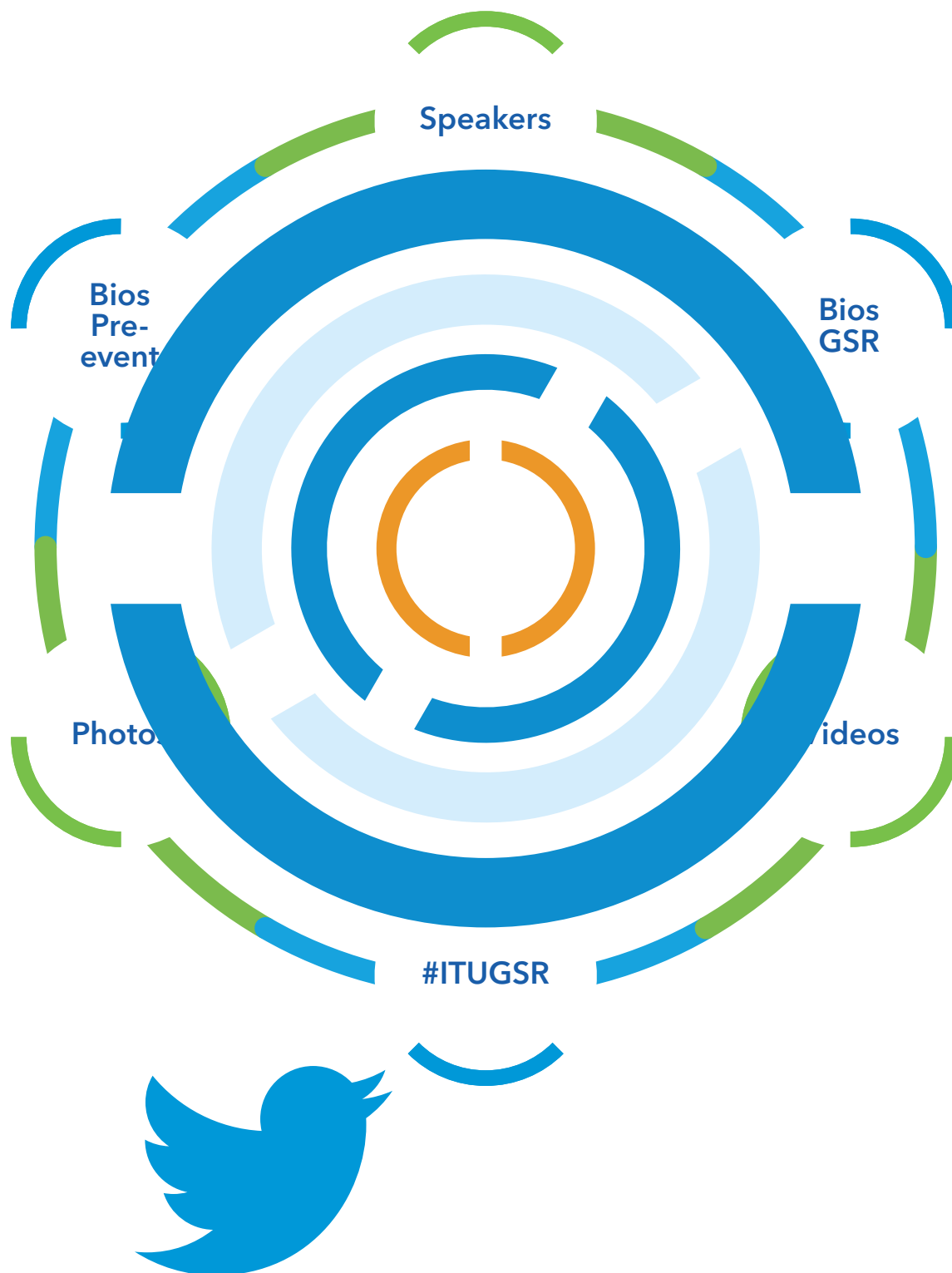

WTDC-17 advances ICTs for sustainable development

Delegates participating in the World Telecommunication Development Conference 2017 (**WTDC-17**), which took place in Buenos Aires from 9 to 20 October, have adopted a forward-looking agenda designed to leverage information and communication technologies (ICTs) towards the achievement of the United Nations' Sustainable Development Goals (**SDGs**) – and to chart the next four-years of the ITU Telecommunication Development Sector (**ITU-D**).

More than 1360 participants, including more than 1010 government delegates representing more than 130 countries, convened in Buenos Aires to specifically review and endorse actions under the WTDC-17 theme "ICT for Sustainable Development Goals (ICT4SDG)". This represented a unique opportunity to realize a "common understanding" on the forward-looking role of ICTs toward achievement of the SDGs, and in so doing, improving livelihoods around the world.

Oscar M. Gonzalez, Argentina's Under-Secretary for ICT Regulation, Ministry of Modernization, was elected Chairman of the Conference.

"The decisions taken at WTDC-17 reaffirm our commitment that ICTs have an important and distinct role to play in the attainment of sustainable development thereby improving the lives of millions of people around the world," said Houlin Zhao, ITU Secretary-General, in his closing remarks. "I am confident that infrastructure will be strengthened, investment will be increased, innovation will be developed, and inclusion will be fostered... bringing a better life to all without leaving anyone behind."

The two-week meeting programme included a **high-level plenary segment** in which ministers and deputy ministers shared their views on emerging trends and on matters of strategic importance to the development of the ICT sector. Knowledge and experience were shared among participants at a series of **side events** on timely issues including cybersecurity, gender, digital skills for youth employment, emergency response telecommunications, digital finance and e-health. Rich strategic discussions were also held at the national, regional and international levels, with many **views and experiences shared**.

WTDC-17 Outcomes

The **Buenos Aires Declaration** states that “universally accessible, secure and affordable telecommunications/ICTs are a fundamental contribution towards the achievement of the WSIS Action Lines and of the 2030 Agenda for Sustainable Development and the development of the global information society and the digital economy.”

WTDC-17 developed and agreed the objectives and outputs that form ITU-D’s component in the overall draft of the ITU Strategic Plan. The forthcoming **ITU Plenipotentiary Conference 2018** to be held from 29 October to 16 November in Dubai, will approve the ITU Strategic plan for the period 2020-2023.

The **Buenos Aires Action Plan** provides a simple, comprehensive and functional instrument for the achievement of the strategic objectives of ITU-D. The Buenos Aires Action Plan, specifically its programmes, regional initiatives and Study Group Questions will further contribute to the implementation of ITU resolutions and recommendations relevant to the mandate of ITU-D, including the ITU Connect 2020 Agenda, the World Summit for the Information Society (WSIS) action lines and Sustainable Development Goals and Targets.

Regional initiatives outlined in the Buenos Aires Action Plan are intended to address specific telecommunication/ICT priority areas, through partnerships and resource mobilization to implement projects. Under each regional initiative, projects will be developed and implemented to meet the region’s needs.



High-level segment

A high-level segment enabled high-ranking officials from ITU Member States, for the most part ministers or deputy ministers, to share their views on emerging trends and on matters of strategic importance to the development of the telecommunication and information and communication technology sector worldwide.

The working methods of the Sector were further improved, the strategic guidelines were developed, resolutions were adopted, and the management teams of the various organs were elected.

As outlined in the Buenos Aires Action Plan, ITU-D study groups are responsible for developing reports, guidelines and recommendations based on input received from the membership for review by their members. Information is gathered through surveys, contributions and case studies, and is made available for easy access by the membership using content-management and web-publication tools. The study groups will examine specific task-oriented telecommunication/ICT questions of priority to ITU-D membership to support them in achieving their development goals.

WTDC-17 also commemorated the **25th Anniversary** of ITU’s Development Sector. The milestone was marked by two Ministerial Roundtables focused on the impact of ICTs for SDGs and the future of the digital economy. This was followed by a Gala Dinner honouring all of the Telecommunication Development Bureau’s Directors and recognizing the contribution made by ITU-D long-standing Members.

Side events

A Lighting session on satellite and the SDGs making a difference by the EMEA Satellite Operations Associations (ESOA) featured ESOA's Ethan Lucarelli, Global Network and Services Policy, and Natalia Vicente, Head of Public Affairs as speakers who explain how satellite communication has a key role in achieving all 17 of the SDGs.

WTDC Women's breakfast, showcased initiatives and shared experiences on facilitating digital skills and job creation opportunities for women and girls. These included steps ITU and its members are taking that are making every day Girls in ICT Day as well as digital skills training programmes and job placement services for young women in support of the Digital Skills for Decent Jobs for Youth campaign.

A lighting session on Argentinian modernization plan (Ministry of Modernization) featured speaker Andrés Horacio Ibarra, Argentina's Minister of National Modernization, Argentina's Minister of National Modernization, who gave an overview of Argentina's 21st Century digital agenda objectives in terms of convergence and digital inclusion.

Digital skills for youth employment in the digital economy explored the latest trends in digital skills for youth employment in the digital economy. It also highlighted the role of ITU in promoting digital skills for youth employment globally and shared the latest developments from ITU Members, the European Commission, the Global Initiative and the joint ILO – ITU Digital Skills for Decent Jobs Campaign.

Academia4SDGs: From research to innovative solutions to accelerate sustainable development saw the showcasing of existing and new pilot ITU-D platforms for Academia engagement and other Academia-led projects and initiatives in

ICT4SDGs. It also provided an opportunity for all academia members to discuss possible ways to strengthen the involvement of academia in the future implementation of ICT4SDGs-related projects and initiatives.

Digital economy: Accelerating digital transformation through innovation provided opportunities to bring together multi-stakeholders to discuss digital innovation frameworks leading towards a common agenda to foster innovation through public service stakeholders, startups, and small- and medium-sized enterprises (SMEs).

Emergency Telecommunications showcased the work of ITU-D in the area of emergency telecommunication deployment and its close cooperation with public and private sector partners, on the occasion of the International Day for Disaster Reduction.

Cybersecurity showcased some ITU Telecommunication Development Bureau (BDT) cybersecurity related flagship initiatives (e.g. the Global Cybersecurity Index (GCI), the National Cybersecurity Strategy project (NCS), among others), in order to collect views and inputs from the membership, so to improve BDT service delivery for the benefit of the Member States.

A Lightning session on UNESCO harnessing ICT4SDG towards knowledge societies was about initiatives which leverage the United Nations Educational, Scientific and Cultural Organization's mandate and strengths in ICT4SDG.

E-Health: ICT for universal health coverage raised awareness on the role of ICTs in achieving greater equity in accessing health services irrespective of socioeconomic status and without incurring financial hardship on people in pursuit and in the spirit of the Sustainable Development Goals.

CELEBRATING 25 YEARS OF ACHIEVEMENTS

Participants at WTDC-17 commemorated the **25th Anniversary** of ITU's Telecommunication Development Sector (**ITU-D**) which was established in 1992 by the Additional Plenipotentiary Conference held in Geneva.

The milestone was marked by two Ministerial Roundtables which focused on the impact of ICTs for the sustainable developments goals (SDGs) and the future of the digital economy.

High-level interventions at the ministerial and head of regulatory authority level were enriched by contributions from representatives of the private sector, civil society, technical community and academia.

This was followed by a Gala Dinner honouring all of the Development Bureau Directors since 1992.

Over the past 25 years, ITU-D has immensely contributed to the rapid growth and expansion of telecommunication/ICT networks and services and continues today, to play a pivotal role in helping countries achieve sustainable development.

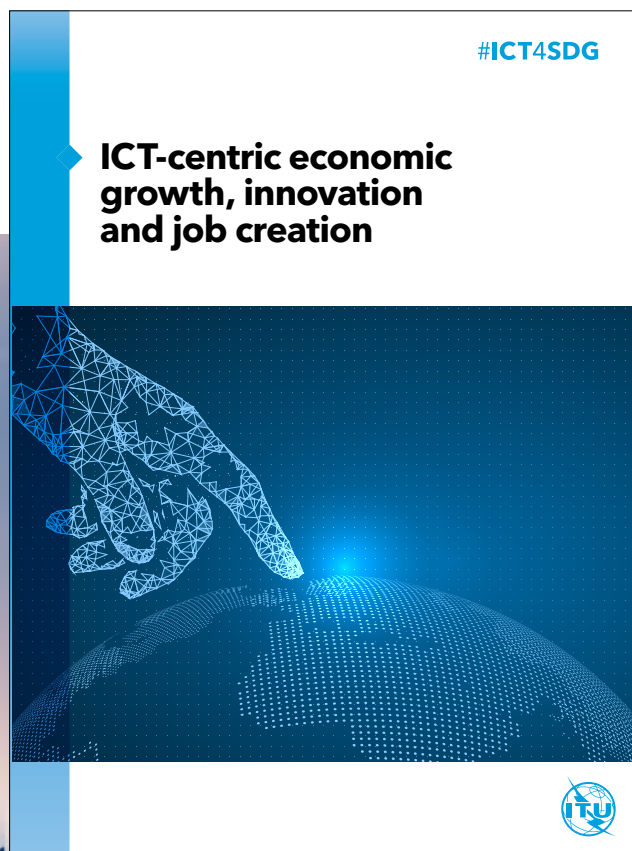

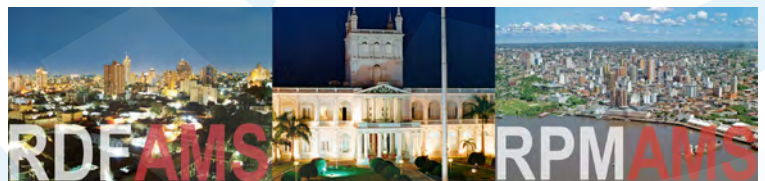

In addition to four new Resolutions adopted at WTDC-17, ITU members modified over 40 Resolutions on a range of topics including ICT services in rural, isolated and poorly served areas; alternative calling procedures; Internet access and availability for developing countries; assistance to countries in special need; the role of ICTs in disaster preparedness; bridging the digital divide; capacity-building initiatives; assistance in implementing future networks; assistance to indigenous peoples; strengthening cooperation among telecom regulators; gender equality; accessibility for persons with disabilities and specific needs; ICT and climate change; child online protection;

National computer incident response teams; ITU Centres of Excellence; support for ICT development in Africa; and combating counterfeit devices.

In addition, members abrogated six Resolutions deemed to have achieved their objectives.

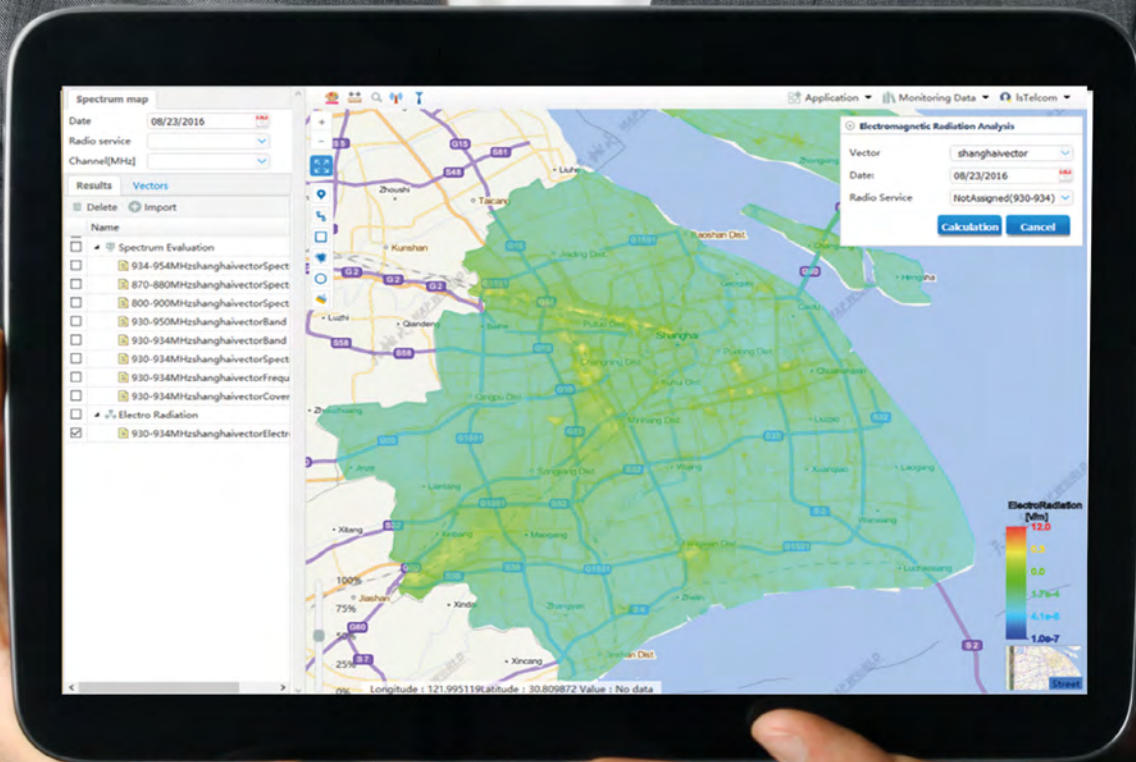
